#### WHAT DO I NEED TO APPLY FOR MY THAI VISA?



#### **Tourist visa:**

- 1. Application Form
- 2. Visa Processing Fee
- 3. Original Passport must be valid for at least 6 months after planned departure from Thailand
- 4. Two (2) recent color passport-sized photographs taken against white background and printed on standard photographic paper
- 5. Proof of sufficient funds 20000 Baht per person approx €520
- 6. Stamped self-addressed pre-paid special delivery envelope

#### If applying for a multiple entry visa you will also need to provide:

- 7. Travel itinerary details to Thailand
- 8. Hotel booking in Thailand
- 9. Proof of resident status in Ireland/ UK (Passport or UK/ Ireland resident card) along with a photocopy
- 10. A letter from your employer in Ireland/ UK, addressed to the Royal Thai Embassy. If self-employed photocopies of self-assessment and company registration documents.
- 11. Original bank statement with at least GBP 5 000 (or the equivalent in EUR).



#### Non-Immigrant (Business) visa:

- 1. Original passport, valid for at least 6 months beyond entry date with at least 1 blank visa page
- 2. Completed and signed visa application form
- 3. 2 recent colour passport size photographs
- 4. Proof of sufficient funds 20000 Baht per person approx €520
- 5. Letter from current employer addressed to the Embassy on company letterhead paper, stating the applicant's name and including the following details:
  - a) Specify the purpose of the visit, the number of entries and the length of the visa required
  - b) The name of the organization to be visited with its contact details
  - c) Include an acceptance of financial responsibility for the applicant
  - d) Be signed by the applicant's supervisor or company's HR Department
- 6. Letter of invitation from the company in Thailand on company letterhead paper, stating the name of the applicant and:
  - a) The purpose of the visit
  - b) The number of entries and the length of the visa required
- 7. Pre-paid, self addressed, special delivery envelope



#### Where should I send my documents?

VISA FIRST, 14 St. Stephen's Green, Dublin 2, Ireland.



#### How long the visa take to be organized?

The processing time is 5 working days.



#### How much time I could spend in Thailand?

The allowed stay on Tourist visas is up to 60 days per entry.

The allowed stay on Business visas is up to 90 days per entry.

#### What's the visa validity?

Tourist visas are valid for 3 or 6 months from the date of issue. The visas are issued as 3-Month Single Entry, and 6-Month Multiple Entry ones.

Business (Non-Immigrant) visas are valid for 3 months or 1 year from the date of issue. The visas are issued as 3-Month Single Entry or 1-Year Multiple Entry ones.
